Yokohama Subsidiary Officially Opens Thai Truck and Bus Tire Plant

Tokyo – The Yokohama Rubber Co., Ltd., today announced that its subsidiary Yokohama Tire Manufacturing (Thailand) Co., Ltd., held the grand opening ceremony on July 15 at its new plant. This subsidiary manufactures and sells truck and bus steel radial tires. Production began in April 2005. The official opening was timed to coincide with the start of shipments. Around 200 people attended the ceremony. They included representatives of Japanese and overseas tire sales companies and Japanese automakers, and Tadanobu Nagumo, president of The Yokohama Rubber Co., Ltd.

Mr. Nagumo said in his speech that: "The new facility's mission will be to fulfill our commitment to provide the best products at competitive prices and on time. We will accordingly cultivate Yokohama Tire Manufacturing (Thailand) so that it becomes our largest comprehensive tire production base outside Japan."

Yokohama Tire Manufacturing (Thailand) was established in January 2004. The first phase of construction finished on schedule in April 2005, resulting in an annual production capacity of 350,000 tires. The facility will export these products to replacement markets outside Japan, including Europe, North America, and Oceania. A second-phase expansion plan will expand production capacity to 700,000 tires a year.
